II. CALL TO ORDER:

The BAC Chairperson called the meeting to order at around 9:00am. After determining the existence of a quorum, the BAC Chairman proceeded to treat the official business of the day.

III. MINUTES OF THE MEETING:

III.A. OPENING OF BIDS

The BAC Chairperson read the Project Title, Approved Budget of the Contract and the bidders who submitted bidding documents for the abovementioned contract. *R8 22-05-0363 Supply and Delivery of Various Materials for official use in the Fabrication of FRP Boats as Assistance to affected Fisherfolk in Region 8 by Typhoon Odette with an ABC of Php 1,971,000.00* received five bidders namely: BASIC-AGRI INDUSTRIAL SALES, SUKI TRADING, POLYMER PHILS.INC, UNI-REAL CORPORATION and TACLOBAN GRACE TRADING.

After acknowledging everyone who attended today's meeting, the BAC Chairman instructed the BAC Sec staff to proceed to open the bid envelope containing the original, technical, legal and financial components of BASIC-AGRI INDUSTRIAL SALES by flashing it to the screen. The remaining copies of the documents marked as "Copy 1 & 2" were examined by the TWG. Same procedure was done to the remaining bidders SUKI TRADING, POLYMER PHILS.INC, UNI-REAL CORPORATION and TACLOBAN GRACE TRADING. After determining the compliance of the requirements using the, non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR), the abovementioned bidders were rated "PASSED" and will proceed to the opening of the Financial Bid Components.

Thereafter, the BAC Sec staff proceeded to the opening of the original copy of the Financial Bid Components of BASIC-AGRI INDUSTRIAL SALES's bid amounting to Php1,534,410.00, SUKI TRADING in the amount of Php948,186.00, POLYMER PHILS.INC amounting to Php1,864,620.00, UNI-REAL CORPORATION amounting to Php1,610,334.00 and lastly TACLOBAN GRACE TRADING amounting to Php1,353,510.00.

After the examination and evaluation, the BAC declares SUKI TRADING CORPORATION as the Lowest Calculated Bid and will advance to the Post- Qualification of the BAC-TWG.

Moreover, the BAC Chairman instructed the BAC Sec staff to proceed to the next agenda of the day.

III. B. OTHER MATTERS

The BAC Sec staff informed the BAC and the end-user regarding the status of the Post Disqualification result/findings of RB NUNEZ CONSTRUCTION for the contract R8 22-02-0149 Labor and Materials for the Construction of Seaweed Storage & Drying Facility at Dawahon Island, Bato, Leyte. The proprietor of RB NUNEZ CONSTRUCTION did not submit any motion for reconsideration regarding the BAC -TWG's findings three days after informing him via email and call. The BAC agreed that it may now be reposted in the Philgeps website under Public Bidding as soon as possible.

Having no more matters/issues to be discussed, the BAC Chairman declares adjournment of the meeting at around 10:40 am.
