III.A. PRE-BID CONFERENCE

BAC Chairperson Atty. Duke Lester B. Chua asked BAC Secretariat staff to show on screen the Philippine Bidding Documents (PBD) of the project and briefly went over the salient features thereof such as the following: a) approved budget of the contract (ABC); b) delivery schedule; c) payment scheme/schedule; d) technical specifications e) terms & conditions

III. C. OTHER MATTERS

The BAC Chairman informed the BAC Members that TACLOBAN GRACE TRADING submitted a bid protest letter regarding the decision of the BAC on the project bid conducted last March 14, 2022 with the project name R8 22-01-0138 Supply and Delivery of Marine Engine with Complete Accessories for the Implementation of Seaweed Projects in Dawahon Island Bato, Leyte in which they have participated. According to the letter, it has come to their attention that the other bidder (KFB MARKETING) has failed to comply and misrepresented there bid document and that they want to appeal to re-evaluate the document submitted by KFB MARKETING and reconsider the BAC's decision.

After some thorough discussions, the BAC agreed that they will wait for the post qualification report of the BAC –TWG within the day for the updates. Immediately after, the BAC continued to tackle/discuss other matters listed for the day.

Furthermore, the BAC Secretariat presented the minutes of the meeting during the pre-bid conference held last March 14, 2022 for some corrections and clarifications. After a thorough discussion, the BAC agreed to come into consensus on the final minutes of the meeting of the pre-bid conference held last March 14, 2022 and further raised a motion for the approval of the minutes as corrected by BAC Member Loreginia Briones. Maam Lea Tumabiene duly seconded the motion. Having no objection to the motion, the chair ruled for the approval of the minutes.
