III. MINUTES OF THE MEETING:

III.A. OPENING OF BIDS

The BAC Secretariat staff informed the BAC Chairperson that the contract **R8 23-01-0029 Procurement of Gasoline, Diesel and Lubricants fir BFAR VIII for FY 2023** with a total Approved Budget of the Contract of Php 6,002,550.00 has NO BIDS RECEIVED during the opening of bids. The BAC Chairperson instructed the BAC Secretariat staff to repost the abovementioned contract in the Philgeps website for second posting under Public Bidding as soon as possible and then commanded the BAC Secretariat staff to proceed to the second contract **R8 23-01-0002 Procurement of Materials to be used for Forty (40) units Seaweed Solar Dryer** with an Approved Budget of the Contract of Php 999,160.00 whereby two bidders submitted their bid proposal namely: 1.) KRYPTON INTERNATIONAL RESOURCES SALES AND SERVICES INC. 2.) TACLOBAN GRACE TRADING INC.

After acknowledging everyone who attended today's meeting, the BAC Chairperson started the opening of bids by instructing the BAC Secretariat staff to open the bid envelope and display on screen the original technical, legal and financial components of KRYPTON INTERNATIONAL RESOURCES SALES AND SERVICES INC. The remaining copies of the documents marked as "Copy 1 & 2" were examined by the BAC- TWG. Same procedure was done to the remaining bidder TACLOBAN GRACE TRADING. Upon checking of the Bid Securing Declaration, the BAC found out that the date was February 28, 2023 and the bidder replied that it was mere typographical error, while the Omnibus Sworn Statement the date was January 28, 2023 signed by the same notary public so the BAC considered it passed subject to post-qualification.

After determining the compliance of the requirements using the non-discretionary "pass/fail" criterion specified in the Implementing Rules and Regulation (IRR), the BAC declared both KRYPTON INTERNATIONAL RESOURCES SALES AND SERVICES INC. and TACLOBAN GRACE TRADING INC. "PASSED" and will proceed to the Post-Qualification of the BAC-TWG. Below was their financial bid amount:
