**III. MINUTES OF THE MEETING:**

**III.A. OPENING OF BIDS**

BAC Sec Staff informed the BAC that contract R8 23-01-0054 Supply and Delivery of Materials for Seaweed Farm Implements for the Implementation of Seaweed Development Program in Region 8 has seven (7) bidders as shown in the table below;

After the BAC Chairperson acknowledged the participants for today's meeting, she instructed the BAC Sec staff to proceed to the opening of bid proposal by showing to the screen the original Legal, Technical and Financial Components of the first bidder DMC ENTERPRISES. The remaining copies of the documents marked as "Copy 1 & 2" were examined by the TWG. The same procedure was done to the remaining six (6) bidders namely VALDEBER INTERNATIONAL TRADING CO., A. COSTA ENTERPRISES, MINDANAO SOLID BAGGING CORP., UNI-REAL TRADING CORPORATION, CS TRADING AND GENERAL MERCHANDISE and TACLOBAN GRACE TRADING. Listed below were the bidders who were rated PASSED and proceeded to the opening of the Financial Bid Components.

BAC Member Loreginia P. Briones raised a motion for the disqualification of UNI-REAL TRADING CORPORATION because they failed to attach the Terms and Conditions set forth for this particular contract and indicate their compliance thereof; duly seconded by BAC- Vice Chairman

Atty. Duke Lester B. Chua. The bidder's representative present during the opening of bids was thereby notified in an open session that if they wish to question the decision of the BAC, they have three (3) days from today to submit a Motion for Reconsideration.

After the examination and evaluation, the BAC declares **VALDEBER INTERNATIONAL TRADING CO. for LOT 1** with a financial bid amounting to Php 788,700.00 and **TACLOBAN GRACE TRADING INC. with a financial bid for Lot 2** amounting to Php 1,383,900.00, as the Lowest Calculated Bid and recommended for the Post- Qualification of the BAC-TWG.

Thereafter, the BAC Vice- Chairman instructed the BAC Sec Staff to proceed to the next agenda for the day.

### **III.B. PRE-BID CONFERENCE**

The BAC Chairperson asked the BAC Secretariat staff to show on screen the Philippine Bidding Document of the project and briefly went over the salient features thereof such as the following: a) approved budget of the contract (ABC); b) delivery schedule; c) payment scheme/schedule; d) technical specifications.

NO CHANGES were made to the bidding documents for the abovementioned contract. The opening of bids for this contract will be on March 13, 2023. Interested bidders may coordinate with the BAC Secretariat for further queries.
