III. MINUTES OF THE MEETING:

III.A. OPENING OF BIDS

The BAC Chairman acknowledged the participants for today's meeting and then instructed the BAC secretariat staff to proceed to the opening of bids by showing on screen the original Legal, Technical and Financial Component of the first contract ITB No: 2023-0004 Supply and Delivery of Brood stock Conditioning Feeds for Legislated Hatchery Project and Bangus Brood stock Maintenance of GMFDC AND LMSH Station with an approved budget of the contract (ABC) of L1: 480,600; L2: 259,200; L3: 537,300; TOTAL: 1,277,100.00. The aforementioned project received a lone bidder namely PACIFICA AGRIVET SUPPLIES INC. as shown in the table below;

The remaining copies of the bid was examined by the BAC-TWG. The BAC examined the bid proposal as to its compliance to the requirements using the non-discretionary "pass/fail" criteria and thereafter was rated "FAILED" by the BAC due to non-disclosure of their all-on-going government and private contract. According to GPPB NPM No.111-2013 states that "Failure to include all ongoing and completed contracts in the Statement may be a ground for disqualification for being incomplete, and may also result in blacklisting if proven that such failure amounts to submission of false information or false documents. The submission of the eligibility documents enumerated in Section 23.1 of the IRR is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the IRR."

Furthermore, the BAC Chairperson instructed the BAC secretariat staff to proceed to the next contract subject for opening of bids and the BAC secretariat staff replied that the remaining two (2) contracts namely R8 23-03-0264 Supply and Delivery of Green Grouper for Grouper Cage Culture in support to SAAD Project Implementation in Samar Province with an approved budget of the contract (ABC) of Php 1,000,000.00 and R8 23-03-0265 Supply and Delivery of various Materials for Grouper and Tilapia Culture in Cage in support to SAAD Project Implementation in Samar Province with an approved budget of the contract (ABC) of Php 1,434,400.00 has NO BIDS RECEIVED.

The BAC Chairperson instructed the BAC secretariat staff to repost the subject three (3) contracts in the Philgeps website under Public Bidding as soon as possible for re-bidding.

Thereafter, the BAC Chairperson instructed the BAC Sec Staff to proceed to the next agenda for the day.

III. D. OTHER MATTERS

BAC secretariat staff presented on screen the Motion for Reconsideration filed by Mr. Joselito Custorio of J. Custorio Construction dated April 12, 2023. After some exchange of ideas, the BAC unanimously agreed to DENY the motion filed by the aforementioned bidder. The BAC Chairman instructed the BAC secretariat staff to make the necessary BAC Resolution regarding this matter.

Having no more matters/issues to be discussed, the BAC Chairman declared adjournment of the meeting at around 11:40 pm.
