### II. CALL TO ORDER:

The BAC Vice-Chairperson called the meeting to order at around 9:00am. After determining the existence of a quorum, the BAC Vice-Chairperson proceeded to treat the official business of the day.

### III. MINUTES OF THE MEETING:

#### III.A. OPENING OF BIDS

The Presiding Officer informed the BAC secretariat to start the opening of bids with contract that has a large number of bid proposals received to be followed by contract with lone/sole bidder. The contract R8 23-04-0290 Procurement of Common-use Office Supplies and Other Supplies not available in PS for official use of BFAR RO 8 for FY 2023 with an approved budget of the contract for L1: 726,210.00; L2: 271,295.00; L3: 2,139,767.00; L4: 61,500.00 TOTAL ABC: 3,198,772.00 received three (3) bidders as shown in the table below:

After the BAC Vice-Chairperson acknowledged the participants for today's meeting, he instructed the BAC Sec staff to proceed to the opening of bid proposal by showing to the screen the original Legal, Technical and Financial Documents of the first bidder ELECTROCOMPUTER DATA SYSTEMS. The same procedure was done to the remaining two (2) bidders namely LEYTE PAPERWORLD and TACLOBAN TAP COMMERCIAL. The remaining copies of the bid was examined by the BAC-TWG. The BAC examined the bid proposal as to its compliance to the requirements using the non-discretionary "pass/fail" criteria. Listed below were the bidders who were rated PASSED and proceeded to the opening of the Financial Bid Components.

After the examination and evaluation, the BAC declares **TACLOBAN TAP COMMERCIAL** for **LOTS 1(455,296.63) and 2(190,218.00)** with a financial bid amounting to **Php 645,6115.65** and **LEYTE PAPERWORLD** with a financial bid for **LOTS 3(2,088,878.00) and 4(59,581.00)** amounting to Php **2,148,459.00**, as the Lowest Calculated Bid and recommended for the Post- Qualification of the BAC-TWG.

The BAC secretariat then proceeded to the opening of the contract R8 23-02-0201(Re-bidding for LOT 1) Supply and Delivery of Feeds and Fingerlings for Livelihood Project under SAAD Program with an

approved budget of the contract of L1:1,380,000.00 whereby one (1) bidder submitted their bid as shown in the table below;

The BAC Vice-Chairperson instructed the BAC secretariat to flash on screen the original Legal, Technical and Financial Documents of the lone bidder PACIFICA AGRIVET SUPPLIES INC., and was found out that they did not attach the required certificate of satisfactory completion of the previous project similar to the subject contract. The BAC declared PACIFICA AGRIVET SUPPLIES INC. "FAILED."

The BAC Vice-Chairperson instructed the BAC secretariat to inform the representative of PACIFICA AGRIVET SUPPLIES INC. and conveyed the result of the opening of bids via text message on that same day and also added that if they wish to contest the decision of the BAC, they are entitled to file a Motion for Reconsideration (MR) within three (3) days upon receipt of written notice or verbal notification.

Moreover, the Presiding Officer instructed the BAC secretariat to post the aforementioned contract in the Philgeps website using the Negotiated Procurement Two Failed Bidding procedure.

Thereafter, the BAC Vice-Chairperson instructed the BAC secretariat to proceed to the next agenda for the day.

### III. B. OTHER MATTERS

The BAC secretariat presented the minutes of the meeting during the procurement activities held last April 24, 2023 and May 02, 2023 for some corrections and clarifications. After a thorough discussion, The BAC agreed to come into consensus on the final minutes of the meeting of the procurement activities held on April 24, 2023, and May 02, 2023 and further raised a motion for the approval of the minutes as corrected by BAC Member Lea A. Tumabiene duly seconded by BAC Member Edmar Kristopher P. Petallana. Having no objection, the presiding officer ruled for the approval of the minutes.

Having no more matters/issues to be discussed, the BAC Vice-Chairperson declared adjournment of the meeting at around 11:09 am.
