### III.A. OPENING OF BIDS

BAC secretariat informed the BAC that the two (2) contracts subject for opening today received a lone bidder as shown in the table below. The remaining contract R8 23- 03-0265 (Re-bidding) Supply and Delivery of various Materials for Grouper & Tilapia Culture in cage in support to SAAD Project Implementation in Samar Province with an approved budget of the contract of Php 1,434,400.00 has no bids received during bid opening. The Presiding Officer instructed the BAC secretariat staff to repost it in the Philgeps website under Negotiated Procurement Two Failed Bidding procedure as soon as possible.

After the BAC Chairperson acknowledged the participants for today's meeting, she instructed the BAC secretariat to proceed to the opening of bid proposal of the contract **ITB No. 2023-0004 Supply and Delivery of Broodstock Conditioning Feeds for Legislated Hatchery Project and Bangus Broodstock Maintenance at GMFDC & LMSH Stations** with an approved budget of the contract of **L1: 480,600.00; L2: 259,200.00; L3: 537,300.00 TOTAL ABC: 1,277,100.00**, by showing to the screen the original Legal, Technical and Financial Documents of the lone bidder **TANDAYA AGRICULTURAL SUPPLY**. The remaining copies of the bid was examined by the BAC-TWG. The BAC examined the bid proposal as to its compliance to the requirements using the non-discretionary "pass/fail" criteria. The same procedure was done to the second contract **R8 23-03-0264(Re-bidding) Supply and Delivery of Green Grouper for Grouper Cage Culture in support to SAAD Project Implementation in Samar Province** with an approved budget of the contract of **Php1,000,000.00**, which received a bid proposal from the lone bidder, **TANDAYA AGRICULTURAL SUPPLY** with the following results:
