


**TERMS AND CONDITIONS:**

**LOT 1**

for the Tactical Uniform

- that the winning bidder must coordinate with the end-user for the design and color of the upper shirt, tactical pants and headgear/cap including the complete set of embroidered patches with magic tape (see attached design);
- that the winning bidder must not supply ready to wear upper shirt, tactical pants and headgear/cap, rather, the items must be made in accordance to the sizes of the intended users of the items.
- that the winning bidder must facilitate together with the end-user in securing the body measurements of users, and that charges will be shouldered by the winning bidder should such fee's is necessary.
- that the winning bidder must have their own tailoring shop business supported with valid business permit and other pertinent documents
- that the winning bidder must use spandex and docker twill cloth or must coordinate with the end-user for the type of cloth that will be utilized
- that the winning bidder must provide 1 complete set of sample finish product to the end-user for approval prior to mass production of tactical uniform
- that the winning bidder must deliver all items to BFAR Regional Office 8 within 30 days upon receipt of purchase order during office hours and must coordinate with the end-user 2 days prior the delivery;
- that the end-user reserves the right to return items not in accordance with the design, color and specifications
- that the winning bidder will be paid after all items have been delivered, papers processed, inspected and accepted by duly authorized BFAR 8 representative

**LOT 2**

for the Tactical Boots

- that the winning bidder must coordinate with the end-user for the color and design of the boots and sizes
- that the winning bidder must provide sample of the boots to the end-user they intend to supply for coordination or approval
- that the winning bidder must provide new stock of tactical boots with supporting documents, boots must have been delivered or made within the last 6 months prior the delivery.
- that the winning bidder must deliver all items to BFAR Regional Office 8 within 30 days upon receipt of purchase order during office hours and must coordinate with the end-user 2 days prior the delivery;
- that the end-user reserves the right to return items not in accordance with the design, color and specifications
