NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **FIVE MILLION FOUR HUNDRED FORTY-THREE THOUSAND EIGHT HUNDRED SEVENTY-FIVE PESOS AND 11/100 ONLY (PHP5,443,875.11)** or such other sums as may be ascertained, **J.A. CONSTRUCTION AND TRADING CORPORATION** agrees to "HEIGHTENING OF FISHPOND DIKES AT RBAPC-LAVEZARES, NORTHERN, SAMAR" in accordance with his/her/its Bid.
