

 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **NINE HUNDRED SEVENTY-THREE THOUSAND SEVEN HUNDRED NINETY-SIX PESOS ONLY (PHP973,796.00)** or such other sums as may be ascertained, **TACLOBAN GRACE TRADING INC.** agrees to "**SUPPLY AND DELIVERY OF FISHING MATERIALS FOR BOTTOM SET GILL NET FOR DISTRIBUTION TO IDENTIFIED FISHERFOLKS IN LEYTE PROVINCE**" in accordance with his/her/its Bid.
