WHEREAS, **BFAR 8** advertised the **Invitation to Bid** for the “**CONSTRUCTION OF 100 LN.M. PERIMETER FENCE WITH 6 UNITS SOLAR LAMP POSTS-PHASE 1 AT RFAPC-BABATNGON, LEYTE**” in the PHILGEPS, BFAR 8 website, and in a conspicuous place at the premise of BFAR 8 continuously for 20 days, commencing from October 07, 2025, until October 27, 2025;

WHEREAS, on October 14, 2025 the scheduled Pre-Bid Conference was **POSTPONED** due to lack of quorum of BAC members, hence, the Pre-Bid Conference was moved to October 21, 2025 as well as the deadline of Submission of Bids to November 03, 2025, 8:30 AM, and the Opening of Bids to November 03, 2025, 9: 00 AM.

WHEREAS, on November 03, 2025 the Opening of bids was **POSTPONED** due to Executive Order No. 4122-2025 issued by the Province of Leyte, which suspended work in government agencies in view of the potential impacts of “Tropical Storm Tino”, hence, the deadline of the Submission of Bids was also moved to November 05, 2025, 8:30 AM and the Opening of Bids was also moved to the same date.

WHEREAS, on November 05, 2025 the scheduled Opening of Bids was **POSTPONED** due to lack of quorum of the BAC members, however, the submission of Bids remained while the Opening of Bids was moved to November 07, 2025 at 9: 00 AM.

WHEREAS, in response to said advertisements, five (5) bidders purchased the bid document and submitted their eligibility, technical, and financial documents on November 05, 2025 but only two (2) was rated “passed” during the preliminary examination of bids.

WHEREAS, the findings of the preliminary examination of bids are detailed as follows:

CONTRACT AGREEMENT


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **NINE HUNDRED FORTY-NINE THOUSAND SIX HUNDRED NINETY-SIX PESOS AND 27/100 ONLY (PHP 949,696.27)**, or such other sums as may be ascertained, **HARDLINE BUILDERS AND SALES** agrees to "**CONSTRUCTION OF 100 LN.M. PERIMETER FENCE WITH 6 UNITS SOLAR LAMP POSTS-PHASE 1 AT RFAPC-BABATNGON, LEYTE**" in accordance with his/her/its Bid.
4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES REGIONAL OFFICE-08** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






