

CONTRACT AGREEMENT

THIS AGREEMENT made the 12th day of December 2025 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES REGIONAL OFFICE 8 (BFAR 08); Leyte SMED Center Senator Enage Street, Tacloban City, Leyte** of the Philippines (hereinafter called "the Entity") of the one part and **LEYTE PAPERWORLD; #168 M.H. Delpilar Street, Tacloban City, Leyte** of the Philippines (hereinafter called "the Supplier") of the other part;

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **FOUR HUNDRED SIXTY-NINE THOUSAND NINE HUNDRED SIXTY-FIVE PESOS ONLY (PHP 469,965.00)** for **Lot 1 only** or such other sums as may be ascertained, **LEYTE PAPERWORLD** agrees to "**PROCUREMENT OF FURNITURE, MACHINERIES AND EQUIPMENT TO BE USED FOR THE OPERATION OF LEGISLATED MULTI-SPECIES MARINE HATCHERY IN BASEY, SAMAR**" in accordance with his/her/its Bid.
4. **The BUREAU OF FISHERIES AND AQUATIC RESOURCES REGIONAL OFFICE 8 (BFAR 08)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





